FINANCIAL STATEMENT for 2015

DEAR PARISHIONERS

It gives me pleasure to be able to share with you the financial statement of the parish for the past year. This is your money and your parish and I hope this breakdown gives you a clear picture of the sources of income and the areas of expenditure.

The increase of income and decrease of expenditure has produced an annual credit balance of £16,000. Savings have been made on personal expenses, assessment fund and utilities. These have been offset against increases in property maintenance and pastoral costs.

I thank most sincerely those of you who, as regular Mass attenders, continue to support the upkeep of the parish, especially through the Gift Aid scheme. It is clear that future demands upon such generosity will be fall upon fewer people.

The parish finance committee is once again active and I am grateful to those who have borne the burden over the years and to the new members who are working together to ensure that everything is correctly accounted for and that we budget carefully for the future.

I would like to add a word of sincere thanks on behalf of the Redemptorist community for your generosity in supporting us not only here in Bishop Eton but also in our mission in Zimbabwe. In the course of the year there are many other charities, which are grateful for your contributions, including our own SVP.

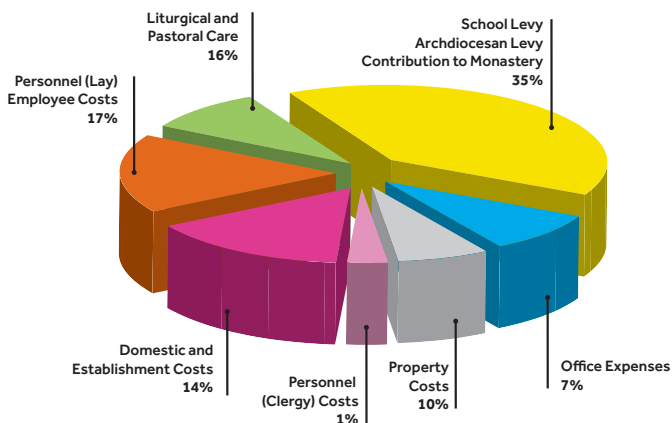

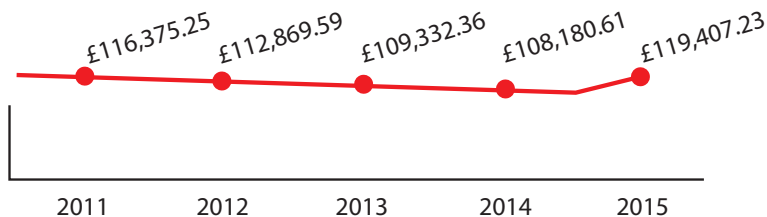
