FINANCIAL STATEMENT for 2013

Dear Parishioners

It gives me pleasure to be able to share with you the financial statement of the parish for the past year. This is your money and your parish and I hope this breakdown gives you a clear picture of the sources of income and the areas of expenditure.

You will see from the figures that in credit by £3,500. The additional expense of organ repairs has been met by a combination of personal contributions, funds from fund-raisers, and the benefit accruing from a legacy. I have also been able to improve the reception facilities at my office. The anticipated spending for 2014 includes repairs to the stained glass window behind the main altar and additional health and safety work.

The steady decline in offertory collections since 2008 continues. Despite this I must sincerely thank

those who attend Sunday Mass regularly and by their generosity sustain the parish.

The parish finance committee is once again active and I am grateful to those who have borne the burden over the years and to the new members who are working together to ensure that everything is correctly accounted for and that we budget carefully for the future.

I would like to add a word of sincere thanks on behalf of the Redemptorist community for your generosity in supporting us not only here in Bishop Eton but also in our mission in Zimbabwe. In the course of the year there are many other charities, which are grateful for your contributions, including our own SVP.

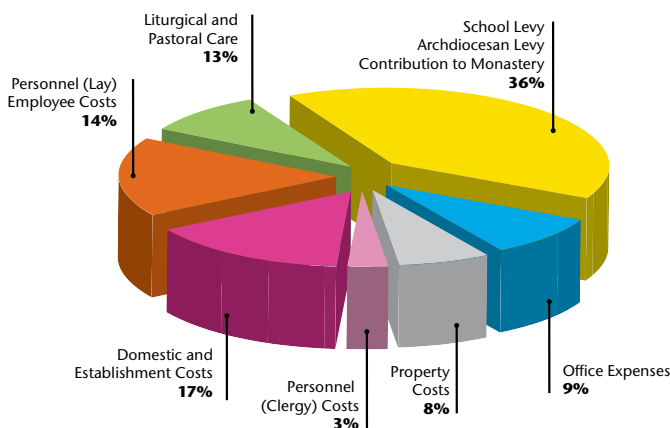

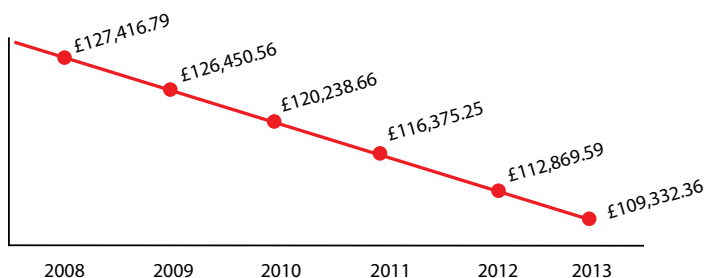
