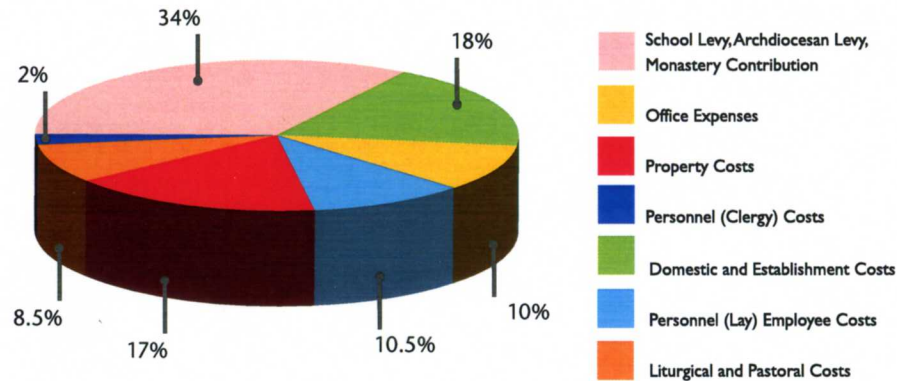

The tax reclaim for 2010 was £21,365.76 which represented a **fall** of almost £2,000 - a potentially dangerous situation - but nonetheless a creditable performance considering all the demands on your finances.

In the coming year the effect of lowering tax thresholds will reduce your claim by about 10%, so.....

Dear Parishioner,

Please find enclosed a brief outline of parish income and expenditure for 2010.

Once again, may I take this opportunity to thank the parish community for your outstanding generosity over the year, not only in supporting the Redemptorist parish and community at Bishop Eton, but also for your wonderful donations towards so many other charities. A special word of thanks for the huge financial help towards the Redemptorists in Zimbabwe and Haiti as they reach out to people in great need and distress in these two countries. The parish can be very proud of this remarkable outreach to people far less fortunate than ourselves.

This year there is an overspend of £12,700. This shortfall is mainly due to expensive property costs and energy bills, coupled with a decrease in offertory donations of £6,000. This decrease in offertory donations is very understandable given the present financial climate. In light of this decrease, however, it is important as ever to think about gift aiding your contributions in order to ensure the parish receives 25% back from Her Majesty's Revenue and Customs.
